- Landscaping requirements adjusted to tables stated on PDP Master Sire Plan (3.08.05 LDC)
- 110% Financial Security waived (3.08.03.D LDC) The City is a partner of the WCEDA
- Platting requirement waived (3.08.06.D LDC). Lots to be frangible in size to provide flexibility
- Sewer/water tap/impact fees and fire impact fees deferred for payment by developers of individual lots, not at PDP Master plan stage.
